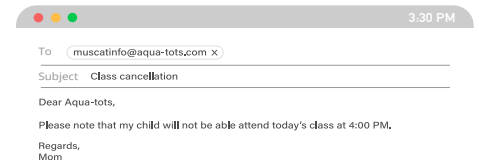

PLAN ON HOLD POLICY

	Plan	No. of Classes
Parents may put the Plan ON HOLD if	1 Day per Week of Plan	Min. 2 Classes or more
Parents may put the Plan ON HOLD if	2 Days per Week of Plan	Min. 3 Classes or more
Parents may put the Plan ON HOLD if	3 Days per Week of Plan	Min. 4 Classes or more

Putting a plan on hold will incur an amount of 5/- OMR per month

Make-up classes cannot be converted to plan on hold.

The maximum plan on hold duration is 12 months.

Only parents can put plan on hold by visiting the school. Plan cannot be placed unless it's paid.

DRESS-CODE POLICY

We highly appreciate parents attending level 1 or 2 (babies) group classes. It is mandatory to wear appropriate swim attire in accordance with the local Omani culture, please note that cotton clothing is not allowed in the pool. 
